Purpose

This policy will provide guidelines for:

- receiving and dealing with compliments and complaints at Hampton Park Care Group Inc.
- procedures to be followed in investigating complaints.

Note: This policy does not address complaints relating to staff grievances or employment matters. The relevant awards provide information on the management of such issues.

Policy Statement

Values

Hampton Park Care Group Inc. is committed to:

- providing an environment of mutual respect and open communication
- recognising excellence and gratitude
- complying with all legislative and statutory requirements
- dealing with disputes, complainants with fairness and equity
- establishing mechanisms to respond to complaints in a timely way
- treating information in relation to complaints with sensitivity.

Scope

This policy applies to the approved provider (HPCH Board of Governance), persons with management or control (EO), nominated supervisor, persons in day-to-day charge, early childhood teachers, educators, staff, students, volunteers, parents/guardians, children, and others attending the programs and activities of Hampton Park Care Group Inc..

Background

Compliments are expressions of praise, encouragement or gratitude about service, staff, management and program. Compliments provide valuable feedback about the level of satisfaction with service delivery and are a valuable indicator of the effectiveness of a service. Compliments impart useful insights about the aspects of service that are most meaningful to children, families and stakeholders, and provide an opportunity to recognise the efforts of staff, foster a culture of excellence and boost morale.

Complaints may be received from anyone who comes in contact with Hampton Park Care Group Inc. including parents/guardians, volunteers, students, members of the local community and other agencies.

In most cases, dealing with complaints will be the responsibility of the approved provider (Board of Governance). All complaints, when lodged, need to be initially assessed to determine whether they are a general or a notifiable complaint *(refer to Definitions).*

When a complaint has been assessed as 'notifiable', the approved provider must notify Department of Education and Training (DET) of the complaint. The approved provider will investigate the complaint and take any actions deemed necessary, in addition to responding to requests from and assisting with any investigation by DET.

There may be occasions when the complainant reports the complaint directly to DET. If DET then notifies the approved provider about a complaint they have received, the approved provider will still have responsibility for investigating and dealing with the complaint as outlined in this policy, in addition to co-operating with any investigation by DET.

DET will investigate all complaints it receives about a service, where it is alleged that the health, safety or wellbeing of any child within HPCH may have been compromised, or that there may have been a contravention of the *Education and Care Services National Law Act 2010 and the Education and Care Services National Regulations 2011*.

Definitions

The terms defined in this section relate specifically to this policy.

Complaint: (In relation to this policy) a complaint is defined as an issue of a minor nature that can be resolved promptly or within 24 hours and does not require a detailed investigation. Complaints include an expression of displeasure, such as poor service, and any verbal or written complaint directly related to HPCH.

Complaints do not include staff, industrial or employment matters, occupational health and safety matters (unless related to the safety of the children) and issues related to the legal business entity, such as the incorporated association or co-operative.

Complaints Register: (In relation to this policy) records information about complaints received at HPCH, together with a record of the outcomes. This register must be kept in a secure file, accessible only to educators and responsible persons at HPCH. The register can provide valuable information to the approved provider on meeting the needs of children and families at HPCH.

Compliment: a compliment is an expression of praise, encouragement or gratitude. It may relate to an individual staff member, a team, the program or HPCH.

Dispute resolution procedure: The method used to resolve complaints, disputes or matters of concern through an agreed resolution process.

Mediator: A person (neutral party) who attempts to reconcile differences between disputants.

Mediation: An attempt to bring about a peaceful settlement or compromise between disputants through the objective intervention of a neutral party.

Evaluation

- regularly seek feedback from everyone affected by the policy regarding its effectiveness
- monitor complaints as recorded in the Complaints Register to assess whether satisfactory resolutions have been achieved
- review the effectiveness of the policy and procedures to ensure that all complaints have been dealt with in a fair and timely manner
- keep the policy up to date with current legislation, research, policy and best practice
- revise the policy and procedures as part of HPCH's policy review cycle, or as required



• notifying all stakeholders affected by this policy at least 14 days before making any significant changes to this policy or its procedures, unless a lesser period is necessary due to risk (Regulation 172 (2)).

Attachment 2. Sample terms of reference for a Emergency & Risk Management Committee /Complaints investigator

DATE ESTABLISHED:

PURPOSE

An Emergency & Risk Management (E&RM) committee has been established by the Hampton Park Care Group Inc. (Hampton Park Community House -HPCH) Board of Governance to manage Emergencies and Risk including investigation of hazards, incidents and/or complaints. This Committee is responsible for investigating and resolving a complaint lodged with Hampton Park Care Group Inc.

An investigator/panel of investigators has been appointed by the board of Hampton Park Care Group Inc. to investigate and resolve compliant lodged with Hampton Park Care Group Inc.

MEMBERSHIP

The E&RM Committee includes at least five people are nominated by the Board, and membership must include a minimum of one responsible person (*refer to Definitions*).

[If a Complaints /investigator or a panel of investigators is appointed]

[at least three members]

TIME PERIOD NOMINATED

Emergency & Risk Management Committee/Complaints investigator shall be appointed on a rotation basis annually.

MEETING REQUIREMENTS

The E&RM convenor/complaints investigator is responsible for organising meetings as soon as is practicable after receiving a complaint.

DECISION-MAKING AUTHORITY

The EM&R Management Committee /Complaints investigator is required to fulfil only those tasks and functions as outlined in these terms of reference.

The approved provider may decide to alter the decision-making authority of the committee/investigator at any time.



BUDGET ALLOCATION

All expenditure to be incurred by the committee/complaints investigator must be approved by the Board or their delegated representative -Executive Officer (Person with Management and Control). A request in writing must be submitted by the E&RM committee/Complaints investigator.

REPORTING REQUIREMENTS OF THE COMMITTEE

The E&RM committee/Complaints investigator is required to keep minutes of all meetings held. These are to be kept in a secure file.

The convenor is required to present a written report to the approved provider about the complaint, ensuring that privacy and confidentiality are maintained according to HPCH's *Privacy and Confidentiality Policy*.

TASKS AND FUNCTIONS OF THE E&RM COMMITTEE/ COMPLAINTS INVESTIGATOR

- Responding to complaints in a timely manner
- Investigating all complaints received in a discreet and responsible manner
- Implementing the procedures outlined in Attachment 2 Dealing with complaints
- Acting fairly and equitably, and maintaining confidentiality at all times
- Informing the approved provider if a complaint is assessed as notifiable
- Keeping the approved provider informed about complaints that have been received and the outcomes of investigations
- Providing the approved provider with recommendations for action
- Ensuring decisions are based on the evidence that has been gathered
- Reviewing the terms of reference of the Complaints Subcommittee/investigator at commencement and on completion of their term. Suggestions for alterations are to be presented to and approved by the approved provider



ATTACHMENT 3. Dealing with complaints

DEALING WITH A COMPLAINT

When a complaint is received, the person to whom the complaint is addressed will:

- inform the complainant of the HPCH's Compliment and Complaint Policy
- encourage the complainant to resolve the complaint with the person directly, or to submit their complaint in writing
- the staff member receiving the formal complaint will record all relevant details in the Complaints Register *(refer to Definitions)* together with the outcome
- assess complaint for severity, safety, complexity, impact and the need for immediate action
- inform the approved provider if the complaint is a notifiable complaint (*refer to Definitions*) or is unable to be resolved appropriately in a timely manner.
- comply with HPCH's *Privacy and Confidentiality Policy* with regard to all meetings/discussions in relation to a complaint
- Domain Area Managers/Supervisors to ensure all complaints are uploaded via the Hazards, incidents, complaints and compliments form via the <u>HPCH Portal</u> and that HPCH's Emergency & Risk Management committee (EM&RM), is informed, or appoint an investigator(s) to investigate the matter
- the EM&R Committee /investigator will assess the complaint to determine if it is a notifiable complaint (*refer to Definitions*)

DEALING WITH A NOTIFIABLE COMPLAINT

When a formal complaint is lodged with HPCH:

- if the complaint is notifiable, the approved provider will be responsible for notifying DET. This must be in writing within 24 hours of receiving the complaint (*Regulation 176(2)(b*))
- the written report to DET needs to be submitted using the appropriate forms from ACECQA and will include:

details of the event or incident

- the name of the person who initially made the complaint
- if appropriate, the name of the child concerned and the condition of the child, including a medical or incident report (where relevant)
- contact details of a nominated member of the Complaints Subcommittee/investigator
- any other relevant information
- if the approved provider is unsure if the complaint is a notifiable complaint, it is good practice to contact DET for confirmation.



EMERGENCY & RISK MANAGEMENT COMMITTEE /INVESTIGATOR RESPONSIBILITIES AND PROCEDURES

In the event of a complaint being lodged, the Complaints Subcommittee/investigator will:

- convene as soon as possible to deal with the complaint in a timely manner
- disclose any conflict of interest relating to any member of the subcommittee/panel of investigators. Such members must stand aside from the investigation and subsequent processes
- consider the nature and the details of the complaint
- identify which service policies (if any) the complaint involves
- inform the approved provider if their involvement is required under any other service policies
- if the complaint is a notifiable complaint *(refer to Definitions)*, inform the complainant of the requirements to notify DET of the complaint and explain the role that DET may take in investigating the complaint
- maintain appropriate records of the information and data collected, including minutes of meetings, incident reports and copies of relevant documentation relating to the complaint
- respect the confidential nature of information relating to the complaint. The approved provider and the subcommittee/investigator must handle any complaint in a discreet and professional manner
- store all written information relating to complaint securely and in compliance with HPCH's *Privacy and Confidentiality Policy*.

INVESTIGATING THE COMPLAINT AND GATHERING RELEVANT INFORMATION

When investigating the complaint and gathering relevant information, the Emergency & Risk Management committee/investigator will:

- meet with individual witnesses, and give right of reply to the person against whom the allegations are made in relation to any accusation or information relating to an alleged incident
- offer the complainant the opportunity of meeting with the subcommittee/investigator to discuss the complaint and provide additional information where relevant
- nominate a subcommittee member to inform the complainant of the procedures for dealing with the complaint if the complainant does not take up the opportunity to attend a meeting
- document the time, date and detail of meetings/discussions, and follow this up with a letter to the complainant outlining the information discussed
- be available to meet with DET staff, if required, and provide additional information as requested
- review relevant information and documents
- obtain any other relevant information or documentation that will assist in resolving the complaint
- seek advice, where appropriate, from individuals and organisations that may be able to assist in resolving the complaint (any cost in seeking advice will require prior approval by the approved provider).

FOLLOWING THE INVESTIGATION

Once the investigation of the complaint is complete, the Complaints Subcommittee/investigator will:

• meet to discuss the information gathered and determine further action, including generating recommendations to be presented to the approved provider



- ensure that any recommendations or actions are in accordance with relevant legislation and funding requirements including, but not limited to:
- Education and Care Services National Law Act 2010
- Education and Care Services National Regulations 2011
- The Kindergarten Guide (*refer to Sources*) report outcomes that may include relevant information gained in investigations and consultations to the approved provider and, where required, provide any recommendations for consideration by the approved provider
- inform the approved provider on the involvement of DET and the outcomes of any investigation by DET. The approved provider will review the report and any subcommittee/investigator recommendations and will be responsible for making decisions on the action to be taken (if any), including relevant review mechanisms
- advise the complainant and other relevant parties of any decisions made by the approved provider in relation to the complaint
- follow up to ensure the parties involved are satisfied with the outcome and monitor progress on any actions taken by the approved provider.
